

Conditions of the Fish Hoek High School Virtual Auction

Information on the Auction Site

Neither Noordhoek Auctioneers nor any of the persons acting for Noordhoek Auctioneers shall be liable for incorrect or inadequate descriptions of items up for sale.

Noordhoek auctioneers shall not be held liable for any error or omission in the information provided on the Noordhoek Auctioneers web site or virtual auction platform. Noordhoek auctioneers will not be held liable for any failure of electronic media systems, web sites or other social media devices.

Registration of Bidders and Privacy

Bidders must register online.

Information pertaining to buyers and sellers shall be used for administrative purposes by Noordhoek Auctioneers alone. Should a buyer wish to remain anonymous within the information available to the public in the virtual auction an appropriate nom de plume should be used when setting up your website account under "Display name."

Noordhoek Auctioneers has no obligation to disclose the name of any buyer to any seller.

After the Auction

The bidder submitting the highest bid at the close of the virtual auction shall be informed of his/her successful bid by email. Payment to Noordhoek Auctioneers must be made with immediate effect. Should payment not be ratified Noordhoek Auctioneers has the right to cancel the sale.

Payment must be made to Noordhoek Auctioneers by the following means: Direct EFT, Payfast EFT or Yoco credit/debit card payments.

The successful seller will be informed of the sale of the art work as soon as the buyers funds are reflected in Noordhoek Auctioneers' bank account (trading as Visual Impact). The seller is required to deliver the art work to Noordhoek auctioneers by arrangement with Noordhoek Auctioneers within 2 working days of closure of the Auction.

Shipment of Sold Items

Noordhoek Auctioneers shall arrange appropriate shipment of the art work to the buyer by special arrangement when the full purchase price has been paid.

This special arrangement being one of the following:

1. Buyers may collect art work from Noordhoek Auctioneers by personal arrangement
2. Local courier service from seller to buyer by special arrangement. The seller will take full responsibility for adequate packaging and protection of the art work from damage during such transport. Noordhoek Auctioneers will not bear any responsibility should such an arrangement fail or art work undergo any damage whatsoever.
3. Noordhoek Auctioneers will arrange courier transfer from Noordhoek Auctioneers at an appropriate fee for such a service. This arrangement will be used in respect of the need for distant local transport within South Africa or internationally.

Local courier fees will be R200.00 per item and international courier fees will be R2000.00 per item.

4. In all the above instances, the seller must bear the cost of packaging .
5. In all instances the buyer must bear the cost of courier services.

Noordhoek Auctioneers does not accept responsibility for any damage to art work outside of its control from the time of the final bid to the time of delivery to the buyer.

Sellers Information

The seller confirms to Noordhoek Auctioneers and the buyer that he/she is the lawful owner of the item on sale.

The seller agrees that Noordhoek Auctioneers has the right to decline to sell any object for any reason at its own discretion without the need for any explanation to the proposed seller.

Commission and Payment by Noordhoek Auctioneers

Items placed on the virtual auction for the Fish Hoek High School will be sold at a commission of 30% which will be the benefit accrued to the above mentioned school after deduction of reasonable costs incurred by Noordhoek Auctioneers. Sellers may, by special arrangement elect to donate a greater commission to the school if they so wish. This special arrangement must be made in writing addressed to Noordhoek Auctioneers before the start of the virtual auction.

Noordhoek Auctioneers will pay sellers their portion of the sale price, 70% unless otherwise stated, within 30 days of close of the auction, unless alternative arrangement are undertaken and agreed upon in writing .
